Both individuals and organizations may be recognized. Candidates must be a Moore County Chamber Member in good standing or employed by a Chamber member at the time of nomination. The Chamber reserves the right to award in one, both, or no category in any given year.

Categories

- Individual—Recognizing the individual efforts of a single person to improve the Moore County community by Advancing Commerce or Community.
- Organization—Recognizing a group or organization working to improve the Moore County community by Advancing Commerce or Community.

Nominee must demonstrate success in one or more of the following areas. *Note: Accomplishments must be documented within the past 12-18 months.*

- Community volunteer - working without compensation for a business, government, or not-for profit organization to better the Moore County community.
- Service to a not-for-profit organization - going above and beyond the call of duty in assisting a not-for-profit complete a project or meet its mission and doing so without compensation.
- Meet a specific need/challenge in the community - demonstrated accomplishment in the face of unforeseen challenges, changes, or adversity.

The deadline for nomination is 5:00 p.m., Wednesday, December 30, 2009. Upon submission, the nominee will receive a full application for review by a select panel of judges. The awards will be presented at the January 28, 2010 Moore County Chamber of Commerce Annual Banquet.
