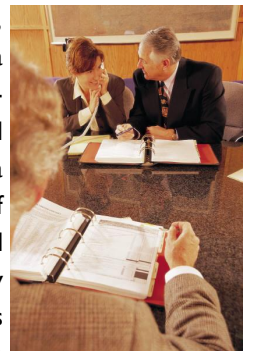
MCLI Graduate Certificate Program

The MCLI Not-for-Profit Management Training Program is a premier program dedicated to providing leadership development, resources, training, and best practices about peak-performing boards. New, veteran and prospective board members, as well as executive directors and staff, will all benefit from participating in the MCLI Not-for-Profit Management Training Program by learning and acting upon the principles of dynamic board leadership.

The Moore County Chamber of Commerce designed this Program as six half-day sessions over a 5-month timeframe. The program is open to MCLI Graduates or anyone seeking additional training and is limited to 25 participants in the class. Sessions will be taught by instructors from the North

Carolina State University's Nonprofit Institute and local leaders involved in nonprofits.

This program is specifically created to make a direct impact here in our community. Individuals participate because they want to help an organization fulfill its mission, enhance career development opportunities, work for a cause they believe in, and develop a strong sense of personal responsibility for the area's future. Not-for-Profit Management

August 15, 2013

Nonprofits in Today's Economy

This session addresses the purpose, benefits and challenges in the nonprofit sector, as well as assesses a nonprofit's function and viability.

September 5, 2013

Mission, Vision, Values and Purpose, Benefits and Challenges in the Nonprofit Sector

This session addresses the development of a nonprofit's mission, vision, and core values. Participants will also receive an overview on methods to recruit new board members, while focusing on diversity, inclusion and creating a board succession plan.

September 19, 2013

Governance and Compliance Issues of Nonprofits and a Nonprofit's Relationship to the Community

This session highlights the structure of the Board of Directors, their specific roles and how they can be more effective. Accountability practices related to policies, procedures, meeting structure and delegation of tasks will also be covered. This session concludes with how to promote a nonprofit and increase awareness in a community.

October 10, 2013

Nonprofit Board Function and Strategic Planning

This session addresses Board roles, responsibilities, and legal and liability issues. There will also be an overview of the creation, monitoring, evaluation and revision of a nonprofit's strategic plan and how it relates to the organization's growth and development.

October 24, 2013

**Financial Management Duties
Reinvigorating the Board**

Financial management of nonprofits, tax issues, fundraising opportunities and ensuring sustainability are other topics featured. In addition learn ways to re-energize your board and providing ways for them to productive board members.

November 14, 2013

**Financial Support and
Making A Difference**

Capitalizing on how you can develop resources to fund your non profit organization. In addition this session summarizes the entire Non Profit program. Participants will discuss their observations of board meetings they have attended* and how each board meeting incorporated the various components of not-for-profit management.
